On March 20th, 2025, the FCC published several changes to the rules around how the carriers that operate the American analog "Plain-Old Telephone Service" (POTS) network are regulated. 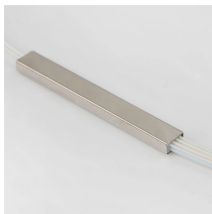
